MANDATING COVID-19 VACCINATION AND PCR TESTING IS NOT LEGAL

As governments and private employers move to **mandate** vaccination and testing for Covid-19, here are facts you **MUST** know to stand strong against the infringement upon your God-given and constitutionally protected Rights and Freedoms.

IT IS NOT A VACCINE

1. Covid-19 "vaccines" do not meet the legal definition of a <u>Vaccine</u> because they do not produce immunity (thus do not prevent infection).

The CDC defines VACCINE as "A product that stimulates a person's immune system to PRODUCE IMMUNITY to a specific disease, PROTECTING the person from that disease."

It defines IMMUNITY as "PROTECTION from an infectious disease. If you are immune to a disease, you can be exposed to it without becoming infected."

Covid-19 vaccines were **not designed** to prevent infection, the science shows that they **DO NOT provide protection** from infection as they **DO NOT produce immunity** from disease; thus they're NOT vaccines.

2. Dr. David Martin in "Focus on Fauci" event, spoke of mRNA jabs and said: "We need to be really clear, we are using the term "vaccine" to sneak this thing under public health exemptions. This is not a vaccine... It is a medical device designed to stimulate the human cell into becoming a pathogen creator...You are getting injected with a chemical substance to induce illness, not to induce an immuno-transmissive response. In other words, nothing about this is going to stop you from transmitting anything. This is about getting you sick and having your own cells be the thing that get you sick."

The same applies for adenovirus based injections such as AstraZeneca, Sputnik V, Johnson and Johnson.

MANDATING EUA COVID-19 "VACCINES" IS NOT LEGAL

1. Covid-19 jabs are **not approved and licensed** by either the Food and Drug Administration (FDA-USA) the Medicines and Healthcare products Regulatory Agency of the United Kingdom (MHRA-UK), the

- European Medicines Agency (EMA-EU) or any other national medicinal regulators. These jabs lack **requisite studies** and are not approved medical treatment
- The Covid-19 injections are permitted under an Emergency Use Authorization (EUA), for investigational use only. The FDA states that Investigational New Drugs are experimental.
- 3. Title 21, Section 360bbb-3 of the Federal Food, Drug, and Cosmetic Act requires that individuals to whom the product is administered are informed "of the **option to accept or REFUSE** administration of the **product**, of the consequences, if any, of refusing administration of the product, and of the alternatives to the product that are available and of their benefits and risks."
- 4. Under the Nuremberg Code, the foundation of ethical medicine, no one may be coerced to participate in a medical experiment. Consent of the individual is "absolutely essential." Applying this principle, the court found that even the U.S. military could not mandate EUA vaccines to soldiers. <u>Doe #1 v. Rumsfeld</u>, 297 F.Supp.2d 119 (2003).

MANDATING COVID-19 PCR TESTING IS NOT LEGAL

- 1. As with EUA "vaccine", PCR tests are EUA medical products only, are experimental and not approved or licensed by the FDA. See points 2-4 of the previous section, which applies to PCR tests also.
- 2. In a Portuguese case the court found that the PCR test "is unable to determine, beyond reasonable doubt, that a positive result corresponds, in fact, to the infection of person by the SARS-CoV-2 virus"-Lisbon Court of Appeal on 11 November 2020 Proc. N 1783/20.7T8PDL.L1. In a similar finding the Austrian tribunal pointed out that the World Health Organization (WHO) had declared that "a PCR test is not appropriate to conduct a diagnosis and, therefore, cannot establish neither the illness nor the level of contagiousness of an individual."
- 3. Furthermore, PCR tests swabs are treated with **Ethylene Oxide** (EO) which is known to be

carcinogenic (cancer causing), mutagenic (changes the DNA in cell) and Spanish Researchers recently found Graphene Oxide (a toxic substance to human blood and organs) in them.
